The airfield is maintained by member volunteers and located at 1020 SE 110th Street located in Southeast Ocala. Our flying site features a 48' wide x 600' long asphalt runway, a parallel grass runway, and plenty of overflight area. There are numerous pilot pit areas with AC power, a large pavilion for gathering, and a dedicated helicopter and drone area. Spectators are welcome daily whenever the gate is open.
